At the November Stated Communication two chances to the Nellis bylaws were proposed based around the dues. These proposed changes are included in this Trestleboard as outlined in Section 4.260 § 5(a) of the Nevada Masonic Code (see below). I have included Section 4.260 of the code so that there's no confusion on the process.

As of this writing the Lodge has not received 2/3 of the membership's dues money. If you haven't remitted you need to. Dues money is due the Lodge by the first of the year and it is sorely needed since our fund raising efforts have not been very successful.

If anyone has input on either the proposed bylaw changes of how to get the brethren to pay their dues I would encourage you to attend the January Stated Communication

Section 4.260 Bylaws.

- 1. Each Lodge shall transmit to the Grand Secretary a copy of its bylaws as soon as adopted,
- 2. No such bylaws nor any subsequent amendment thereof are valid until approved by the Grand Lodge, though they may be acted under until the next Annual Communication if approved by the Grand Master.
- 3. The bylaws of each constituent Lodge must state the hour and the day for its stated communication.
- 4. A copy of the bylaws, printed, mimeographed or otherwise reproduced, shall be given to:
- (a) Each Master Mason at the time he signs the official bylaws of the Lodge.
- (b) Each Master Mason elected to membership by affiliation.

5. An amendment of a bylaw is not effective unless all members of a Lodge have been duly notified of such proposed bylaw amendment prior to the stated communication at which the ballot on the change is conducted. Publishing the proposed bylaw amendment in the trestleboard of the Lodge, mailed to each member, or a timely notice sent through the United States Postal Service, to each Lodge member, shall constitute proper notice. An amendment of a bylaw is not effective until all members of the Lodge are duly notified of its adoption by trestleboard or United States mail as specified herein. As used in this subsection, "amendment" includes:

(a) Changing an existing bylaw.

(b) Addition of a new bylaw.

(c) Repeal of an existing bylaw.

In accordance with <u>Section 10.220</u> of the Masonic Code – Grand Lodge F. & A.M. of Nevada:

These <u>AMENDMENTS</u> will be voted upon at the Nellis Lodge No. 46 Stated Communication on <u>February 6, 2018</u> which is at least 30 days following receipt of these notices.

The following amendment to the Lodge By-Laws was proposed at the stated communication of November 7, 2017

Prior to amendment:

Article XI, Section I & II, reads as follows:

SECTION I. The dues of each member of this Lodge shall be Fifty-five [\$55.00] dollars per year plus Grand Lodge per capita and any Grand Lodge expenses passed to the Lodge, commencing January 1 of each year.

SECTION II. Any member of the Lodge against whom charges are not pending and whose dues and indebtedness to the Lodge are paid may withdraw from membership by presenting a written application therefor at a Stated Communication. The Lodge shall grant the request of the Brother by dropping his name from the rolls and his membership shall be thereby be terminated, and he shall be subject to the disabilities of an unaffiliated Master Mason; provided, however, that an elected officer cannot withdraw.

After amendment: (The proposed change is highlighted)

Article XI, Section I, II, III, will read:

SECTION I. The dues of each member of this Lodge shall be Fifty-five [\$55.00] dollars per year plus Grand Lodge per capita and any Grand Lodge expenses passed to the Lodge, commencing January 1 of each year.

SECTION II. Dues are payable to the Lodge by January 1 of the subsequent year. If current dues are not paid before April 15th of that year, a second notice will be mailed with an additional late fee of \$20.

SECTION III. Any member of the Lodge against whom charges are not pending and whose dues and indebtedness to the Lodge are paid may withdraw from membership by presenting a written application therefor at a Stated Communication. The Lodge shall grant the request of the Brother by dropping his name from the rolls and his membership shall be thereby be terminated, and he shall be subject to the disabilities of an unaffiliated Master Mason; provided, however, that an elected officer cannot withdraw.

Prior to amendment:

Article XI, Section I & II, reads as follows:

SECTION I. The dues of each member of this Lodge shall be Fifty-five [\$55.00] dollars per year plus Grand Lodge per capita and any Grand Lodge expenses passed to the Lodge, commencing January 1 of each year.

SECTION II. Any member of the Lodge against whom charges are not pending and whose dues and indebtedness to the Lodge are paid may withdraw from membership by presenting a written application therefor at a Stated Communication. The Lodge shall grant the request of the Brother by dropping his name from the rolls and his membership shall be thereby be terminated, and he shall be subject to the disabilities of an unaffiliated Master Mason; provided, however, that an elected officer cannot withdraw.

After amendment: (The proposed change is highlighted)

Article XI, Section I & II, reads as follows:

SECTION I. The dues of each member of this Lodge shall be Fifty-five [\$55.00] dollars per year increasing by ten dollars [\$10] in 2019 then additional ten dollar [\$10] increases annually concluding in 2029. Plus Grand Lodge per capita and any Grand Lodge expenses passed to the Lodge, commencing January 1 of each year.

SECTION II. Any member of the Lodge against whom charges are not pending and whose dues and indebtedness to the Lodge are paid may withdraw from membership by presenting a written application therefor at a Stated Communication. The Lodge shall grant the request of the Brother by dropping his name from the rolls and his membership shall be thereby be terminated, and he shall be subject to the disabilities of an unaffiliated Master Mason; provided, however, that an elected officer cannot withdraw.
